Section 5. Fire-Fighting Measures

Section 6. Accidental Release Measures

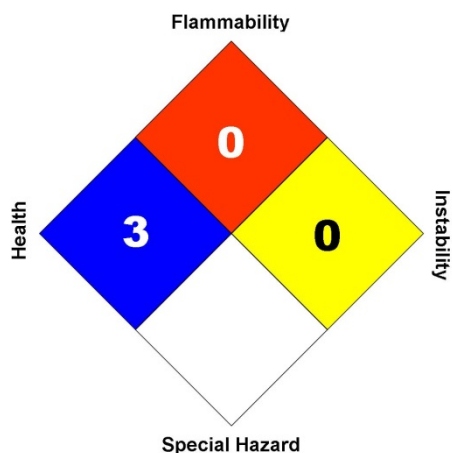
